### **rent and charges**

This lease is granted and accepted subject to the overall price of € ..... including charges that the lessee must pay for the entire duration of his stay, excluding the following charges:

Electricity: free package 500 kWh / week 0.1 € / kWh beyond.

Water: flat rate of 20m<sup>3</sup> / week (30m<sup>3</sup> / week with the orangery), 3 € / m<sup>3</sup> beyond.

### **Security Deposit**

As deposit guarantee and damage that could be caused to local or personal property and / or objects furnishing the premises, the lessee will pay the day of entry into the premises, the sum of € 1,200, (1500 € with the orangery).

This sum, not productive of interest, will be returned once the evidence presented by the lessee as:

- All he had to carry drinks and listed in the previous paragraph has been paid in full;
- No furniture, object or linen is missing, damaged or dirty, or if this is the case, the rehabilitated or replaced by identical agreed with the landlord who accepted;
- The places have suffered no damage and are delivered by state (floors, kitchen, closets, bins, refrigerator, toilets, appliances, dishes, ...).

If the bond proves insufficient, the lessee of already committed perfecting the sum.

### **insurance**

The lessor undertakes to provide housing against rental risks on behalf of the tenant, the latter having the obligation to report to it, within twenty four hours, any accident occurring in the house, outbuildings or accessories.

### **Payment schedule**

### **Terms and conditions**

This lease is made to the usual charges and conditions and law in such matters and the lessee undertakes in particular to:

- Not destine-residential premises without causing any nuisance (noise, odors, smoke, lights, etc.);
- Yield nothing or sublet in any case this lease, even free of charge without written agreement of the lessor;
- Allow the lessor to carry out any repairs whose urgency and necessity appear during the rental and without claim to compensation or rent reduction.

**Penalty clause**

**- deposit**

It is agreed that in case of withdrawal:

- The lessor is required to pay within seven days after the withdrawal, double the deposit to the tenants.

- The tenant will lose the deposit if he withdraws more than three weeks before the lease takes effect; if he withdraws less than three weeks before the lease takes effect, it also will pay the owner the difference between the deposit and the total rent, as penalty clause.

It is recommended to the lessee to purchase insurance cancellation upon signing the contract for the event of cancellation for force majeure (illness ...).

**- Late payment**

It is agreed that in case of delay with payments:

- The lessor will cancel automatically and immediately booking.

- The balance of your rent will be increased by the perception of the minimum statutory interest, is one and half times the legal interest rate. Penalties for late payment are due without necessity of a reminder.
